Annex B: Your Rights

Depending on your location and your relationship with Computacenter the following rights in law may relate to the personal data Computacenter processes about you:

- the right to request from Computacenter access to your personal data;

- the right to request from Computacenter restriction of processing of your personal data;
- the right to object to Computacenter processing of your personal data, including opting out of marketing communications;
